## **Angela María Rosales**

Angela María Rosales is the Chief Program Officer and interim Chief Executive Officer of SOS Children's Villages International, managing the organization operating in 136 countries. Prior to this role, she led SOS Children's Villages Colombia for over 12 years, where she innovated quality care services tailored to local contexts and centred on children and young people. She also led national level coalitions to advance children's rights. Her extensive background includes work with UNDP, national NGOs, and the Colombian government.



#### Katarina Ivanković Knežević

Katarina Ivanković Knežević is a Director for Social Rights and Inclusion in the Directorate General for Employment, Social Affairs, and Inclusion. Her area of activity is modernisation of social protection systems and wider social policies fostering social and labour market inclusion, through the implementation of the European Pillar of Social Rights and other relevant social policies of the European Union. She is leading a project on disability and inclusion and is also DG EMPL Equality Coordinator. Before joining the European Commission, she was State Secretary in the Ministry of Labour and the Pension System of the Republic of Croatia, responsible for the management and implementation of the European Social Fund and other EU instruments aiming at human resources development.



#### **Dr Salma Nims**

Dr Salma Nims is an international consultant on gender and social inclusion and WPS. She has served as Secretary General of the Jordanian National Commission for Women from 2014-2022, and Senior Social Affairs officer on Gender and Social inclusion at UN ESCWA 2022-2024. She holds a PhD and MSc from University College London and has 20 years in gender equality and inclusion in development. Dr Nims served on several global and regional committees and task forces including the UN High-level Task Force on Financing for Gender Equality. In 2019, she received Said Foundation Outstanding Achievement Prize, for her contributions to the development of the Arab region.







#### Nicola Oberzaucher - Moderator

Nicola Oberzaucher joined SOS Children's Villages International in 2005, initially leading the area of family strengthening, and currently serves as Director Programme for the region Central and Eastern Europe, Central Asia, and Middle East. Dr Chrissie Gale has a career spanning more than 30 years promoting child rights with specific reference to child protection and alternative care in an international context. She has worked in many different regions combining her professional expertise in the employ of international bodies and organisations such as UNICEF, UNHCR, UNWRA, Save the Children and Oxfam with an academic career. Until recently, Dr Gale led the international work for the Centre for Excellence for Children's Care and Protection (CELCIS) in the University of Strathclyde during which she managed a global portfolio of child protection programmes and knowledge exchange opportunities. She remains affiliated to the University as a Senior Honorary Research Fellow as well as a Lecturer at the ASH University in Berlin.







#### **Dr Joumana Yeretzian**

Journana Yeretzian is an experienced biostatistician and public health researcher with a PhD in health management and a ScM and BSc in Biostatistics. She is currently an associate professor at the Higher Institute of Public Health at the Saint-Joseph University of Beirut, Lebanon, and serves as the coordinator of the Epidemiology and Biostatistics track and the director of the Centre for Collaborative Research Initiatives in Public Health. Journana has over 25 years of working experience in the health sector. Her research interests include designing and analysing epidemiological studies, exploring, and assessing public private partnerships for healthcare governance and strengthening and optimizing health information systems.



#### **Prof. Charlotte Bredahl**

Charlotte Bredahi has research experience from social work and health services research with children in out-of-home care, children in psychiatric treatment and children with chronic illnesses. ## Kateryna Novokhatnia

Kateryna Novokhatnia is the First Deputy Head of the Coordination Centre for Family Upbringing and Child Care Development under the Cabinet of Ministers of Ukraine. With over 13 years of experience in the child protection sector, she leads reform efforts to transition Ukraine's child care system from institutional to family-based care. At the Coordination Centre, Kateryna leads international collaboration, plans, and monitors reform initiatives in 10 demonstration regions, and manages key coordination platforms—the Council of Regions and the Coalition of CSOs.



#### **Aaron Greenberg**

Aaron Greenberg joined the UNICEF Regional Office for Europe and Central Asia as Senior Child Protection Regional Advisor in July 2017, working to support governments across Europe and Central Asia on issues related to child protection. Prior to this, Aaron served as chief of child protection in Georgia and in Myanmar where he directed UNICEF's support to government and NGO partners around social welfare, child care and justice reforms. Aaron is an internationally recognized expert in the area of child protection system reforms, with a particular focus on alternative care and social services.



#### **Mathis Porchez**

Mathis Porchez works for the Directorate-General for Employment, Social Affairs & Inclusion of the European Commission, in a unit in charge of social (investment) policies. He supports Member States in the implementation of the European Child Guarantee to ensure children in need have access to a set of key services and benefit from the same opportunities as the others. He among others took an active part in the development of a common framework to monitor the implementation of the Guarantee at the EU level. He also deals with policies aiming to reduce child poverty.

Maria Dantcheva serves as the Deputy Programme Director at SOS Children's Villages International, focusing on the IOR CEE/CIS/Middle East region. Her work involves monitoring trends in the development of alternative care services, providing technical expertise, and offering consultation and capacity building. Before taking on this role, Maria spent over 15 years as a Programme Advisor at SOS Children's Villages Bulgaria, where she consulted on the implementation of alternative care, youth development, and family strengthening programs. Maria has more than 20 years of experience in consulting NGOs on child welfare reforms and developing community-based social services that effectively support the needs of children and families.

#### Prof. Mark Jordans

Mark Jordans, PhD, is Professor of Child and Adolescent Global Mental Health at the Center for Global Mental Health, King's College London, and Professor Child and Adolescent Global Mental Health at the Amsterdam Institute of Social Science Research, University of Amsterdam. He is a child psychologist and works as Director of Research & Development for the NGO War Child in the Netherlands. His research interests are the development, implementation, and evaluation of psychosocial and mental health care systems in low- and middle-income countries, especially for children in adversities and in fragile states.



#### **Hadil Al Faqih**

Hadil Al Faqih is the Program Director of the SOS Children´s Village Amman. She is a licensed clinical psychologist by profession and is a seasoned psychologist with 2 master's degrees, the latest in Global Mental Health from Columbia University. 






## Rimvydas Augutavicius - Moderator
